#### SPECIAL ONE DAY WORKSHOP FOR BOARD MEMBERS

It will provide a briefing on the responsibilities of directors, issues which are of particular relevance to board members of state, public and not for profit bodies, and key characteristics of board effectiveness.

The workshop will include presentations from individuals with extensive experience of boards and committees operating with public interest mandates. The workshop will be of value to new board members, to members who would like to receive an up to date briefing and to others who work closely with Boards. It will take account of the most recent Governance Codes, including the Code of Practice for the Governance of State Bodies (2016). Participants will have the opportunity to raise issues of particular interest.

- Key relationships: Board, Management, Ministers and Government Departments, and otherstakeholders
- Differences in the governance of public interest and private sector organisations

The workshop will be led by Aidan Horan, Tom Ward and Kate O'Donnell. All have extensive experience working with and advising on governance, risk, audit and strategy to State Bodies and other non-profit organisations.

- Relationship with Government
   Departments, public agencies, other stakeholders.

- Audit, risk management.
- Meeting information and assurance requirements.
- Meeting reporting requirements.
